## **East County Senior Center Transportation Program Guidelines**

This program is provided by the East County Senior Center & is partially funded by a grant from The City of Monroe.

1. You must be 60+ years of age or 18+ and disabled.
2. Weight including wheelchair or scooter must not exceed 400 pounds.
3. The service operates on Mondays, Thursdays, and Fridays, unless it is a holiday. The first pick-up is at 8:30 a.m. and the last drop off is at 3:30 p.m.
4. There is a 20 minute window of time for pick-up and drop-off.
5. Call 794-6359 to schedule your ride. Three days notice is requested but a minimum of 24 hours notice is required to use the service. If this notice cannot be given, we will do our best to provide transportation but this will not always be possible.
6. Service is provided on a first-come first serve basis. There is no guarantee we will be able to provide transportation to everyone who wants it.
7. If a ride needs to be canceled, 24 hours notice is requested.
8. Standing rides can be arranged for your convenience. However, after three no show/no call, (bus arrives for scheduled pick up and rider isn't there or refuses ride for whatever reason) you will not be able to use the standing ride option and will have to call in to request your ride in the future.
9. Suggested donation of \$1.50 each way to help pay for this program, no one will be denied a ride because of inability to pay.
10. The Senior Center does not provide emergency transportation for medical reasons. Please call 911 for this purpose.
11. You must be able to self-transfer. The driver cannot lift you. The driver can help lift items such as walkers and groceries which weigh less than 25 pounds.
12. Riders with memory issues must be accompanied by a caregiver.
13. Pets will be allowed as long as proof of health and immunizations are provided, the pet is friendly and well-mannered, and the pet is appropriately leashed or kenneled.
14. No smoking, chewing of tobacco, open beverage containers, firearms, or weapons of any kind are allowed on the bus.
15. No tipping is allowed.
